

Livestock RV Application Instructions

In order to reserve a RV camping space during the Sonoma County Fair, livestock exhibitors must submit the following:

A Completed RV Application

Proof of Liability Insurance

Provide a copy of your liability insurance listing your Motor Home, 5th Wheel, Trailer or Camper on your insurance

Form of Payment – check or credit card authorization form

Checks will not be cashed and cards will not be ran until space is assigned

- Please submit all items to the entry office by Friday, June 8 by 5:00 pm
- Please note that due to limited number of RV space, submission of application **DOES NOT** guarantee a reservation of RV space.
- Spaces are assigned according to the priorities listed on page 1 of the application.
- Fairgrounds staff will contact applicants between July 18-20 to let them know status of application; If a space is available for your RV, then you will be assigned a space number and your payment (check or credit card) will be deposited or processed.

Due to limited space, livestock RV's will reside in "D" lot for 2018. Spaces will not have Hookups. There are showers and restrooms for your use in "D" lot. Generators will be allowed, and may ONLY operate between the hours of 9 a.m. – 9 p.m.

AN INCOMPLETE FORM WILL NOT BE ACCEPTED AND WILL BE RETURNED. All Applications must be received by Friday, June 8 at 5:00 p.m. Spaces are allocated based on the criteria below, priority and need, versus the order that applications are received. **All applicants will be notified via mail or email sometime during the week of July 18-20 about the status of their application.** Space numbers will be assigned at that time.

Applications will be prioritized in the following order: 1) Open Exhibitors, 2) Dairy Exhibitors with Lactating Cattle, 3) Junior Breeding Animal Exhibitors. Every effort will be made to accommodate as many RV/Trailers as possible but there are very limited numbers of RV/Trailer spaces available and not everyone will get a space.

Exception: For those Reservation Periods starting on or before Thursday, August 2nd; you can arrive any time after 9 a.m. on the first day of the above-mentioned Reservation Period.

Rules & Regulations**

The Sonoma County Fairgrounds reserves the right to refuse service and modify RV Park rules and regulations.

If you are a Junior Exhibitor – **YOU MUST HAVE AN ADULT CHAPERONE - NO EXCEPTIONS**

Report to the entrance gate for spotting. No one will be allowed to enter the RV Park without the RV Host accompanying you to your designated spot.

RV Park Camp Host is on-site to enforce rules and regulations of the Sonoma County Fairgrounds RV Park. Camp Host can be reached by phone at (707)293-8410. Anyone found in violation of these rules will have his or her privileges revoked and will be removed from the RV lot. RV Park Camp Host will have the final say in all disputes.

ABSOLUTELY NO UNREGISTERED GUEST WILL BE ALLOWED IN THE RV PARK.

Important: RV/Trailer space is for the time animals are on exhibit only. Full fees will be required for hold overs. Only one personal vehicle per RV/Trailer space will be allowed and only if it fits within designated area. Any unattended personal vehicles parked in the RV Park will be towed at the owner's sole expense. A designated area will be reserved for vehicles owned by RV/Trailer park registered renters, only for vehicles too big to fit within RV space. All vehicles must display the proper permit at all times to re-enter the RV Park. Additional vehicles must have a proper permit to leave and re-enter and may not stay overnight, at anytime, for any reason. Driving or parking off road is not permitted.

Speed limit is 5 MPH – Drivers must obey all traffic signs and operate their vehicles in accordance with posted regulations and applicable Federal, State and local laws.

Dogs/Cats running loose will be impounded at the owner's sole expense. Aggressive dogs/cats of any breed are not welcome in the RV Park. Dogs/cats are NOT allowed on the fairgrounds. No dogs/cats may be left unattended. All dogs/cats must be on a leash no longer than 6' (six foot) and under control and in visual observation of their owners at all times when they are outside of the owner's RV or vehicle. Dogs/cats are not allowed to be tied up and left unattended. Dogs running loose will be impounded at the owner's sole expense. Uncontrolled barking will not be tolerated at anytime. Dogs must be cleaned up after immediately.

Anyone under the age of 18 **MUST** be accompanied by a parent or guardian.

All personal equipment must be kept neat and tidy within your assigned site. RV sites must be kept clean for the enjoyment of all our guests. Leave natural areas the way you find them. Do not carve, chop, cut or damage any trees in the RV Park.

At no time may an extension cord be stretched across a road or fire lane to supply electricity to other RV's or stock trucks. No multiple tie-ins will be allowed. Electrical cords must be in good condition and extension cords must not interfere with foot traffic.

No alcoholic beverages are allowed outside of RV/Trailer space. Drugs, weapons, fighting, lewd conduct, reckless driving, speeding, motorized/non-motorized skateboards not permitted and will be grounds for revocation of privileges.

NO LOUD RADIOS OR MUSIC AT ANYTIME: Quiet hours are between 10:00 p.m. and 7:00 a.m. No loud talking or generators. Please be considerate of others. Disorderly conduct will not be tolerated.

VEHICLES OF ANY TYPE ARE FOR ACCESS TO AND FROM RV SITE ONLY. Racing, exhibition of speed and driving off road are STRICTLY FORBIDDEN AND WILL RESULT IN IMMEDIATE REMOVAL FROM THE RV PARK.

NO TENTS ALLOWED.

NO BLACK OR GREY WATER IS TO COME INTO CONTACT WITH THE GROUND: Rinse holding tank basin after each use.

NO FIRES ALLOWED: Fully contained barbecue grills and camping stoves are okay.

NO LITTERING: Littering of the RV Park, RV Site or RV Restrooms will not be tolerated. This includes smoking materials. Extinguish and properly dispose of all smoking materials in proper receptacles (NOT ON THE GROUND). Place garbage and litter in containers provided.

The Sonoma County Fair does not guarantee you will receive a space and reserves the right to refuse or revoke service and to modify rules and regulations at anytime, without notice.
