Cancellations prior to May 24, 2019 will result in a \$35.00 cancellation fee. No refunds will be given for cancellations or incomplete applications after May 24, 2019.

Rules & Regulations

All vehicles entering RV lot must provide proof of valid, current vehicle insurance.

Report to the RV Park Office for vehicle spotting ~ No one will be allowed to enter the RV Park without the RV Host accompanying RV/Trailer to designated spot.

RV Park Camp Host is on-site to enforce the Rules and Regulations of the Sonoma County Fairgrounds RV Park. Camp Host can be reached by phone at (707) 293-8410. Anyone found in violation of these rules will have his or her privileges revoked and will be removed from the RV lot. RV Park Camp Host will have the final say in all disputes.

ABSOLUTELY NO UNREGISTERED GUEST WILL BE ALLOWED IN THE RV PARK. Only one personal vehicle per RV/Trailer space will be allowed and only if it fits within designated area. Any unattended personal vehicles parked in the RV Park will be towed at the owner's sole expense. A designated area will be reserved for vehicles owned by RV/Trailer park registered renters, only for vehicles too big to fit within RV space. All vehicles must display the proper permit at all times to re-enter the RV Park. Additional vehicles must have a proper permit to leave and re-enter and may not stay overnight, at anytime, for any reason. Driving or parking off road is not permitted.

Speed limit is 5 MPH – Drivers must obey all traffic signs and operate their vehicles in accordance with posted regulations and applicable Federal, State and local laws.

Aggressive dogs of any breed are not welcome in the RV Park. All dogs must be on a leash no longer than 6' (six foot) and under control and in visual observation of their owners at all times when they are outside of the owner's RV or vehicle. Dogs are not allowed to be tied up and left unattended. Uncontrolled barking will not be tolerated at anytime. Dogs must be cleaned up after immediately. No dogs allowed on fairgrounds property outside of RV Park.

All personal equipment must be kept neat and tidy within your assigned site. RV sites must be kept clean for the enjoyment of all our guests. Do not carve, chop, cut or damage any trees in the RV Park.

At no time may an extension cord be stretched across a road or fire lane to supply electricity to other RV's or stock trucks. No multiple tie-ins will be allowed. Electrical cords must be in good condition and extension cords must not interfere with foot traffic.

No alcoholic beverages are allowed outside of RV/Trailer space. Drugs, weapons, fighting, lewd conduct, reckless driving, speeding, motorized/non-motorized skateboards not permitted.

NO LOUD RADIOS OR MUSIC AT ANYTIME: Quiet hours are between 10:00 p.m. and 7:00 a.m. No loud talking or generators. Please be considerate of others. Disorderly conduct will not be tolerated.

NO TENTS ALLOWED.

NO BLACK OR GREY WATER IS TO COME INTO CONTACT WITH THE GROUND: Rinse holding tank basin after each use.

NO FIRES ALLOWED: Fully contained barbecue grills and camping stoves are okay.

This contract licenses the holder to park one RV/Trailer/Motorhome/Camper and one vehicle as directed at his/her own risk. The management hereby declares itself not responsible for and assumes no liability arising from fire, theft, damage to or loss of the vehicle or any article left therein. Only a license of space is granted hereby and no bailment is created. Acceptance of this contract constitutes acknowledgement by holder that he/she has read and agrees to the provisions of the foregoing contract and conditions itemized on the Rules and Regulations. Vehicles parked in violation are subject to tow-away at owner's sole expense.

The Contractor agrees to indemnify, release, defend and save harmless the Sonoma County Fair and Exposition, Inc., its Board of Directors, the County of Sonoma, its Board of Supervisors, and the officers, agents, and employees of each of them harmless from any and all claims of loss, damage, injury, liability claim or expense of any nature whatsoever arising in any respect, directly or indirectly resulting to any person, firm or corporation including Contractor arising out of or in connection with the performance of this contract.

By signing this RV Park Vehicle Registration Form, I hereby acknowledge that I have received and read the Rules and Regulations for the Sonoma County Fairgrounds RV Park and accept responsibility for all occupants in the assigned RV Space and that any violation of said Rules and Regulations will result in immediate removal from the Sonoma County Fairgrounds RV Park and other action deemed appropriate by the Management.

The Sonoma County Fair does not guarantee you will receive a space and reserves the right to refuse or revoke service and to modify rules and regulations at anytime, without notice.
